# BELIZE PORT AUTHORITY TERMS OF REFERENCE

#### **Procurement of Patrol Boat for Marine Enforcement Unit**

The Belize Port Authority (BPA) is committed to maintaining maritime safety, enforcing applicable regulations, and ensuring compliance within Belizean waters. As part of its mandate, the Authority is enhancing its enforcement presence within Belize and requires the procurement of a new patrol vessel to support the Marine Enforcement Officers.

## **Objective**

To procure a high-performance patrol boat suitable for daily enforcement operations in coastal and nearshore environments. The vessel will support the Authority's monitoring activities, safety inspections, and general patrol duties, ensuring greater compliance with national legislation and a safe and secure maritime environment.

## **Scope of Supply**

The BPA invites individuals or qualified companies to submit quotations or proposals for the supply and delivery of a new vessel with the following minimum specifications:

## 1. Vessel Specifications

- Between 30 feet and 32 feet
- Fiberglass hull, suitable for coastal waters
- Center console configuration
- Equipped with a bimini top for sun protection
- Built-in aluminum fuel tank with a capacity of 100 gallons

# 2. Engine Requirements

- Two (2) outboard engines
- Minimum 150 HP each
- Electric start with safety cut-off switch
- Regular gasoline engine

# 3. Equipment (Preferred/Optional Additions)

Proposals that include the following additional equipment will be evaluated favorably:

- VHF Marine Radio
- Navigation lights
- GPS and Depth Finder/Fish Finder
- Battery system with selector switch
- Fire extinguisher(s) and basic safety gear (life jackets)
- Bilge pump (automatic and manually operated)
- Anchor with chain and rope
- · Console storage, and dry compartments

## **Delivery Location**

The vessel must be delivered fully assembled and operational to the Belize Port Authority Headquarters in Belize City.

- Delivery address will be provided upon award of contract.
- Supplier must coordinate with the Marine Enforcement Unit for acceptance.

## **Eligibility Requirements**

Suppliers must demonstrate capability and reliability to provide the vessel within the required timeframe.

### **Evaluation Criteria**

Proposals will be evaluated based on:

- Compliance with Specifications
- Delivery Timeframe
- Price and Warranty
- Additional Equipment Offered

#### **Submission Deadline**
