### **Call for Applications**

# Registration and Appointment of Recognized Security Organizations (RSOs) for Port Facilities in Belize

The Belize Port Authority (BPA), as the Designated Authority under the International Ship and Port Facility Security (ISPS) Code and the Belize Port Authority (Security) Regulations, 2011, hereby invites competent and qualified maritime security entities to apply for registration and appointment as Recognized Security Organizations (RSOs) authorized to operate within Belize.

This initiative forms part of the Authority's ongoing efforts to enhance national maritime security and strengthen port management systems. Successful applicants will be authorized to provide professional ISPS-related services to Belizean port facilities, including:

- Conducting Port Facility Security Assessments (PFSAs)
- Preparing or reviewing Port Facility Security Plans (PFSPs)
- Conducting ISPS Code training, drills, and exercises
- Supporting security compliance audits and inspections in accordance with the ISPS Code and national legislation.

#### **Application Process**

Interested organizations are invited to submit a Notice of Interest along with all required documentation as outlined in the attached BPA/OPS/SEC/RSO-2025-1.1 – Criteria for the Appointment of a Recognized Security Organization.

Approved applicants may be invited for an interview or on-site audit to verify capacity and expertise. Successful applicants will be formally notified of the outcome and will receive an official Letter of Appointment and be entered into the BPA's register of approved RSOs.

#### **Conditions of Appointment**

 Appointments will be valid for two (2) years, subject to satisfactory performance and continued compliance with BPA oversight.
